

OFF-LICENCE*Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012*

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), The Pokeno Whisky Company Limited is authorised to sell alcohol on or from the premises situated at 22 Gateway Park Drive Pokeno and known as The Pokeno Whisky Company, to any person for consumption off the premises, to deliver it somewhere else, and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

- (a) No alcohol is to be sold or delivered on Good Friday, Christmas Day, Easter Sunday, or before 1.00 pm on Anzac Day.
- (b) **Only alcohol in the form of spirits which are manufactured on the premises may be sold**, and only during the following days and hours:
Monday to Sunday 11.00am to 7.00pm.
- (c) Drinking water must be freely available to customers at the following places while alcohol is being supplied free as a sample on the premises:
 In the body of the premises near to where the samples are being provided.
- (d) No intoxicated persons may be allowed to enter onto or to remain on the premises.
- (e) Appropriate signage regarding the restrictions on the supply of alcohol to minors and intoxicated persons must be prominently displayed adjacent to every point of sale.
- (f) The whole of the premises is un-designated.
- (g) *The licensee shall not offer to customers, whether remotely or on the premises, any 'buy now pay later' options. The licensee shall not accept 'buy now pay later', as a method of payment for the sale or supply of alcohol to any customer, regardless of whether the 'buy now pay later' is executed through a third party or not. This condition does not apply to payments made by a standard bank credit card. For clarity the purpose of this condition is to ensure the object of the Act is achieved in that payment in full is made at the time of sale and/or supply of alcohol.*
- (h) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
 (i) All staff will be trained in their responsibilities under the Act.
 (ii) A sign shall be prominently displayed inside the premises, which identifies by name the manager on duty or of the person responsible for the management of the sale and supply of alcohol under the licence.
- (i) The sale, supply and consumption of alcohol is authorised on the premises generally. The premises situated at 22 Gateway Park Drive, Pokeno are more precisely identified in a plan date stamped as received by the Waikato District Licensing Committee on 27 May 2022.

Display of Licence

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 22 Gateway Drive is designated as the principal entrance.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) until its expiry date detailed below; OR
- (b) if an application for the renewal of the licence is duly made before the licence expires, until the close of the period 3 years after the expiry date.
